Types of Early Years Funding

Supported Two-year-old funding

A child will be entitled to 570 funded hours a year from the term after both the child has attained the age of two and the child or parent meets the eligibility criteria.

Where a child is in receipt of Supported Two-year-old funding they will continue to receive their funded place until the point when the child becomes eligible for the Universal Funding, even if the child or parent ceases to meet the eligibility criteria during this time.

Some parents maybe be eligible for Funded Two's and 2-year-old working parent entitlement. In this instance providers are asked to claim Funded Two's for the first 15 hours and working family entitlement for the second 15 hours. You will receive two codes – EWB for Funded Two's and a working family code.

Universal Three- and- Four-year-old Funding

All three- and four-year-olds are entitled to 570 funded childcare hours a year. Regulation requires us to validate a child's age. Parents will need to provide evidence of a child's birth date (normally a passport or birth certificate). Copies will not be retained.

Working Families Funding

Working Families Funding is for qualifying working parents with a child aged 9 months or older, 2, 3 or 4 years old. A child will be entitled to 1140 funded hours a year from the term after they have attained the relevant age and the eligibility criteria, set by the government, has been met.

Parents must apply for a positive determination of eligibility from HMRC via Childcare Service Account i.e. a valid eligibility code. This eligibility code must be provided to us before the Early Years Funding can be claimed. The parent is responsible for re-validating the eligibility code every three months. Failure to do so may result in the Working Families Funding being withdrawn. Codes must be applied for or reconfirmed before the start of the term. If a code is issued or reconfirmed after the start of the term, the funding cannot be claimed until the start of the following term as long as it remains valid.

Parent Declaration Form

Regulation requires childcare providers to enter into a separate funding agreement with parents, called the Parent Declaration Form.

Local authorities require parents to complete a Parent Declaration Form covering the Early Years Funding. The local authority Parent Declaration form must be signed each term. If the local authority Parent Declaration Form is not signed and returned to us Early Years Funding cannot be claimed and the full fees (without the Early Years Funding applied) will be charged to you.

Required documentation

Regulation requires childcare providers to obtain documentation to evidence eligibility for the Early Years Funding as per below:

- Supported Two-year old Funded Childcare: Child's birth certificate or passport, confirmation of eligibility (e.g. local authority confirmation letter/email or code).
- Universal Funded Childcare: Child's birth certificate or passport; and
- Working Families Funding: Child's birth certificate or passport, parent's full name, date of birth, eligibility code issued by HMRC, and national insurance number.

Additional documentation may be needed depending on local authority requirements.



Child absences

Each local authority has its own policy on child absences during Funded Childcare. Grove Villa must keep the local authorities informed of child absences and the local authority has the right to recover funding payments made during long-term periods of absences. Parents are responsible for paying Grove Villa for any funding payments reclaimed by the local authority due to a child's absence.

Local authority role

Each childcare provider enters into an agreement with the local authority to provide the Early Years Funding. The local authority pays the childcare provider directly for the Funded Childcare it provides to the eligible children. The parents of the eligible children do not have access to, or the right to access, the Early Years Funding paid by the local authority.

Other types of funding

Special Educational Needs and/or Disability (SEND) Funding

Every local authority has a SEND inclusion fund to support providers in meeting the needs of individual child with SEND. SEND Funding is paid directly to the provider by the local authority. SEND funding is allocated based on the individual needs of a child.

Grove Villa will use SEND Funding to support the child with any learning and developmental delay or special educational needs or disability by accessing specialist resource and equipment and/or additional staff.

Disability Access Funding (DAF)

DAF is available to children in receipt of Disability Living Allowance and Early Years Funding. Local authorities are responsible for checking that the DAF eligibility criteria are met. It is a one-off annual payment directly to the provider. If the child changes provider during the year, the DAF will remain with the original provider. If a child attends more than one provider, then the parent must allocate the DAF to one provider. This funding cannot be shared across providers.

Grove Villa will use any DAF to support making reasonable adjustments/adaptations to enable the child to have equal access to the provision in the same way as any other child or for resource that will be beneficial to the child.

Grove Villa will liaise with the child's parents and engage with any relevant professionals to ensure that DAF is spent appropriately.

Where we have more than one child accessing DAF, we may use the money for all children to support an adjustment or purchase resource that will benefit more than one child.

Any resources purchased as part of DAF remain the property of Grove Villa and can be used to support future children to access the provision.

Early Years Pupil Premium (EYPP)

EYPP is additional funding that Grove Villa can claim to help improve outcomes of eligible children. The local authority pays the EYPP directly to the provider.

EYPP is available to support children whose parents meet the eligibility criteria and are in receipt of Early Years Funding.

Local authorities are responsible for checking that the EYPP eligibility criteria are met.

Grove villa will use EYPP funding to support positive impacts on the child's development.



Deprivation Funding

Deprivation Funding is paid directly to Grove Villa by the local authority.

Depravation Funding is available to support children whose parents meet the eligibility criteria and are in receipt of Early Years Funding.

Local authorities are responsible for checking that the Deprivation Funding eligibility criteria are met.

The eligibility criteria are set by the local authority (which varies per local authority) and may take into account: -

- Child's postcode
- Eligibility for Support Two-year-old Funding
- Eligibility for EYPP

Grove Villa will use Deprivation Funding to close the gap in attainment of children in the nursery.

Early Years Funding explained & entitlements from September 2025

Early Years Funding is a national scheme, administered by local authorities, which offers funded childcare hours with an Ofsted registered provider. A variety of funded hours are available depending on the child's age and the family's situation.

Childcare providers can choose how to offer the Early Years Funding if the following parameters are met: -

- Funded childcare cannot be longer than 10 hours in a single day.
- Funded childcare must be accessed between 6am and 8pm; and
- Funded childcare is available at a maximum of two childcare sites in a single day.

Eligibility dates

The tables below show the funding period and the dates a child turns the eligible age to receive the funding for that period.

Grove Villa's Early Years Funding Offer

Grove Villa wants to make sure that families use their funding to its full potential.

At Grove Villa we want families to be able to maximise their funded childcare by using up to 10 hours of funding a day before purchasing additional hours and without any artificial break in the day.

The updated DofE guidance issued to Local Authorities and providers has made it even more challenging to be able to deliver funded hours in a sustainable way. Many nurseries and childminders are either restricting when in the day they will offer funded hours or lowering the amount of funding hours they will deliver per week. We are pleased to say that Grove Villa will remain with a funding policy which allows parents to claim 10 hours per day and their full entitlement of funded hours per week. This gives our families more flexibility and better value for money.

Stretched Funding

As an all-year-round childcare provider we stretch the early years Funding across 50 weeks instead of limiting it to 38 weeks of term time.

- **15 hours of funded childcare** over 38 weeks (term time) equates to 570 funded childcare hours a year. Under GV's stretched offer this equates to 11.4 hours of funded childcare a week over 50 weeks of the year.
- **30 hours of funded childcare** over 38 weeks (term time) equates to 1,140 funded childcare hours a year. Under GV's stretched offer this equates to 22.8 hours of funded childcare a week over 50 weeks of the year.

Funding is available in 10-hour blocks and begins at 8am. The breakfast session (7.30am to 8am) can't be included as part of a funded hours offering.

How your weekly funding entitlement is deployed

- **15 hours (11.4 stretched)** Where a parent is eligible for 11.4 funded hours a week, the first day of the week they attend will use the number of funded hours that that session runs from i.e., 8am to 6pm will use 10 hours of funding.
- **For fully funded only places are capped at 10 hours**. For families wanting to book additional paid for hours, we will allow the remaining funded-hours allocation to be carried over to the 2nd day with the additional paid for hours booked on top of this.
- **If you require the breakfast session** (7.30am to 8am), this can be added to the session and is invoiced separately.
- **30 hours (22.8 stretched)** Where a parent is eligible for 22.8 funded hours a week, the first day and second day of the week they attend will use the number of funded hours that that session runs from i.e., 8am to 6pm will use 10 hours of funding per day.
- For fully funded only places are capped at 10 hours per day. For families wanting to book additional paid for hours, we will allow the remaining funded-hours allocation to be carried over to the 3rd day with the additional paid for hours booked on top of this.
- If you require the breakfast session (7.30am to 8am), this can be added to the session and is invoiced separately.

Booking pattern

Grove requires parents to confirm their booking pattern when they register their child. As per the registration terms and conditions, at least a month's notice is required to make amendments.

Grove Villa can make permanent changes to booking patterns by providing at least one month's notice to the parent.

The Challenges that the new Department for Education guidance places on childcare providers

Early Years Funding is intended to cover the delivery of childcare only. It does not cover the cost of meals and snacks, non-food consumables or additional hours. The funding is intended to solely cover the delivery of the EYFS (Early Years Foundation Stage) but does not consider all the extra-curricular activities and events that Grove Villa continually provides to enhance the children's learning and development.

Anything deemed a 'business cost' (which includes staff wages, rent, utilities, rates etc.) are not allowed to be part of any funded hours related charges. These costs alone account for over 80% of the total overheads of the business. From September the funded hours scheme is expanding so that all age groups will be able to access the 30 hours scheme which means that a large majority of income that the nursery will receive will be direct from the government early years funding scheme. This leaves only a small percentage of income from private (non-funded hours related) fees to cover the 80% of overheads. In addition, the level of funding that childcare providers receive typically increases marginally each year (3%-4% for 2025 to 20026), yet the cost of employing staff, utilities, food and consumables has increased by over 10% year on year over the last few years.

The big change in how childcare providers offer funded hours to parents is that the DofE now states that:

- A provider must make all additional charges voluntary
- The free entitlement must be used for the delivery of the EYFS.

This means that from the 1^{st of} September we will no longer be able to call the additional charge 'sustainability charge'. This used to allow us to at least make up some of the shortfall between the chronically underfunded funded hours scheme and the cost of providing an all-inclusive enhanced experience for all the children – it covered all meals, consumables and the costs for extra-curricular activities, events and resources. It also helped to maintain a good level of investment in the setting. We now must ask parents to voluntarily opt-in to all the additional elements of the childcare which we used to offer as standard.

Cambridgeshire County Council have also taken the view that some of the enhanced services we currently offer are 'business costs' (other local authorities do not share the same opinion) and we are not allowed to charge for them. For example, Tapestry is a tool that provides parents with valuable insights and updates on their child's day and something we do not have to provide. This is therefore not an essential cost and thus not a business cost, but it costs the nursery to have this license and takes a lot of staff time to make sure you are kept updated on the progress of your child and their development. We intend to keep offering this to all children but it maybe something we will need to review in the future if the operating costs to the business continue to increase exponentially verses to the funding rates.



Voluntary additional charges

From September 1st, 2025, all additional charges must be voluntary. The early years funding that nurseries receive is to deliver the EYFS only. Nurseries can ask parents to 'voluntarily' opt-in to additional charges, but a parent must have the opportunity to opt-out of these. Nurseries can ask parents to opt-in to various services such as food and consumables as well as services and events that are extra-curricular and enhance a child's learning and experience of nursery.

The following is a list of the additional services that are available to opt-in to:

Meals & Snacks

Cost = £0.75p for morning snack, £0.75p for afternoon snack, £4.00 for lunch and £3.50 for afternoon-tea. For part-funded sessions, any meals that fall within funded hours entitlement will be charged. Any meals that fall under 'additional hours' will not be charged and are included.

From the 1^{st of} September, parents will be able to opt-out of the meals and snacks provided by Grove Villa Childcare and supply a pack lunch for their child. We are not allowed to refuse this, but we would strongly discourage you from doing this for several reasons. Mealtimes provide an important social opportunity for the children to sit down together and talk to one another and the staff. They also learn important independent skills such as counting the number of children they need to set the table for, clearing their plates away after eating and helping to tidy up.

By eating the meals and snacks that Grove Villa prepares and serves, the children are all eating the same home-made healthy and allergen free food. Eating the same meals together ensures that children's attention is not drawn away from what is on another child's plate. A child eating a different meal means that other children may want that child is eating and therefore not eating what is on their own plate as well as potentially disrupting meals times.

We also must strictly adhere to both healthy eating and allergen control to ensure there is no cross-contamination which could harm a child with a food allergen or dietary preference.

Parents can choose to provide all meals that their child requires during the day, or opt-in for certain meals and snacks.

Providing a pack-lunch

If a parent wishes to provide a pack lunch, it must comply with our healthy policy, contain no allergens and be provided in a sealed lunch box with an ice pack to keep it col during the day - we simply don't have the space in our refrigerators for storing pack lunches.

The 'healthy eating & food allergy policy' and 'pack lunch policy' will be sent to any parent wishing to provide meals for their child and is available on Grove Villa's website. A signed agreement to adhere to these policies will be required prior to packed meals being provided.

If you are wishing to provide a pack lunch, on arrival at the nursery a member of staff will need to check the contents of the foods provided to make sure it complies with the nurseries healthy eating and pack lunch policies. The adult dropping off the child will be required to tick a pack lunch form to confirm that the pack-lunch box supplied complies with these policies. If the meal/meals supplied do not comply to the healthy eating policy, we will not accept the parts of the meal/meals that contravene either of these polies. If any part of the pack lunch contains ingredients with allergens, all foods within the lunchbox will not be allowed on the premises to avoid the risk of cross-contamination to children with food allergies.

We are required to offer food to every child at snack and mealtimes. If Grove Villa needs to supply a substitute for part of a pack lunch, or all the meals the child requires during their day, there will be a charge for this. These are charged at a higher rate of £1.50 each for morning and afternoon snack, £6 for lunch and £5 for afternoon tea to account for the additional administration involved in invoicing and providing additional ingredients that may need to be purchased at short notice.



We serve morning snack at 10am, lunch at 11:30am, afternoon snack at 2pm and afternoon-tea at 4.30pm. Pack-lunch boxes will not be refrigerated so it is important that if you are providing meals, during your child's day that you pack enough food and consider the perishability of the foods you provide. If not enough food for the day is provided, or we deem the food a potential health risk i.e., an afternoon snack that may have perished in the lunch box, we will supply your child a meal at the costs listed above.

Please also do not provide drinks. Children have constant access to water. Milk (or milk alternative supplied by paraent/carer) is provided at morning-snack time. We do not allow juices, milk/yoghurt drinks or soft drinks to be given to the children whilst they are at nursery. We reserve the right to pour away any of these items if they are discovered in a child's bag or belongings.

Consumables

Grove Villa can provide ALL consumables at additional daily charge of £2 for children requiring nappies and £1 for children who are out of nappies. (calculated pro-rata based on a full 10 hour day for part funded sessions)

You must tick the relevant opt-in box in the 'Additional charges' selection section in the 'Policy Agreement' section of this document.

You can provide the consumables that a child requires during their nursery day (apart from PPE aprons and gloves). This includes nappies, wipes and nappy/skin creams. You will need to tick the opt-out box in the 'Additional charges' selection section in the 'Policy Agreement' section of this document.

We are unable to differentiate between the different consumables as an opt-out i.e., you can't opt-in for creams and opt-out for wipes. By opting out you are agreeing to supply all the consumables that your child requires. You will also need to make sure you write your child's full name on everything supplied in ink that will not easily run off. This ensures that the staff know which child the supplied consumables are for. If any consumables are not properly labelled, they will not be provided to your child. If the consumables supplied run out and are not replenished, or are not labelled, Grove Villa will provide these to your child at a cost of £2 per day for nappies, £1.50 per day for wipes and £1.50 per day if nappy/skin cream is required.

Grove Villa does not supply Sun Cream due to the risk of cross-contamination when applying cream from the same bottle to different children. All parents are required to provide sun cream for their child.

Special events, clubs and extra-curricular activities

All childcare providers must cover the seven areas of learning set out in the EYFS. At Grove Villa we have always gone above and beyond this by making sure the children have an enhanced curriculum and experience (additional to the EYFS requirements). This incurs costs to the nursery. Prior to 1st September 2025 these costs were absorbed in the sustainability charge. From 1st September 2025, we are now required to ask you to voluntarily contribute to the cost of these.

Grove Villa celebrates lots of events throughout the year where children take part and create things that are additional to the learning requirements around 'understanding the world'. We also have several activities and regular outings which were all included as part of our funding policy. From 1st September 2025, these extra religious, culturally significant events, special activities and outings will be offered as an additional service.

Similarly, we will be launching some new clubs that you may wish your child to take part in as an additional service. As a nursery with an outdoor ethos, there will be a nature discovery club along with care home visits for the pre-school.



Care Home Visits (Pre-School)

Cost = £2 per week

Grove Villa has a partnership with Saxon Manor Care home where the pre-school children visit the elderly residents. The children really enjoy going and the residents at the care home are always thrilled to have them visit. We regularly visit on a Wednesday morning and provide additional food and resources for the children take part in activities with the residents. Occasionally we are unable to visit due to inclement weather, staff annual leave or sickness or if the care home is unavailable for us.

Cooking Club (Toddlers and pre-school)

Cost = £1 per week

Learning about food and nutrition and using ingredients to prepare food is popular with the children. Each child in the toddler and pre-school rooms will take part in Cooking Club once a week. It will be run on different days of the week to ensure that each child can take part. If you choose to opt-out of paying the additional charge, you will be required to supply the ingredients required for each week's recipe in order for your child to take part.

Nature Explorers Club (All ages)

Cost = £2.50 per week

Nature Explorers gives children the opportunity to learn about the natural world. They will go on regular outings to discover the wildlife around the woods adjacent to the cricket pitch and the nature reserve and take part in hands-on activities using equipment and resources brought to enhance their experience. One week they may go on a bug hunt, the next try to make a den or help put up a tent. At the setting we will run regular nature explorers' sessions where resources such as activity books and caterpillar farms will be provided.

This is an opt-in only option. If you would prefer to opt-out, then your child will not take part in any of the sessions.

Special events and extra-curricular activities package (All ages)

Cost = £3 per funded day (calculated pro-rata based on a full 10 hour day for part funded sessions)

Grove Villa is committed to providing children opportunities to learn and take part in events and activities that provide an enhancement to the standard learning of the EYFS. Whilst the children will of course learn about the world, take part in physical activities, be taught British Values etc. as part of the EYFS, Grove Villa will offer a special events and extra-curricular activities package to enrich their learning and experience.

We have planned a full calendar celebrating culturally significant dates and dedicated world days where the children may make something to honor this, create something for their family, use props specially brought bring their imagination to life, play with and use additional resources or have a traditional meal. These events include; Mother's Day, Easter, World Book Day, Father's Day, Pride, Eid, Diwali, Pass-Over, St Patrick's Day, Chinese New Year, Comic Relief, Halloween, November 5th, Christmas, Rosh Hashana, Navratil, Black History, Remembrance, Road Safety week, Winter Wonders, Christmas Lunch, Science Week, Pet Month, Earth Day, Space Day, Dinosaur Day, Teddy Bears Picnic, Shark Week, Graduation Celebration (pre-school leavers), etc.

We will also have visits across the year from specialist coaches/children's entertainers such as dance movement, sports coaching, animal ranger etc. These are to be confirmed.



Grove Villa Funding Agreement

Please tick either the opt-in or opt-out box for each of the additional services. When you have done this, please sign the Grove Villa Funding Agreement at the end of this document and either give a hard copy to the nursery manager or email the signed agreement to grovevilla@hotmail.com

This current funding policy does not have a set time limit and will run until either an updated local authority provider agreement requires us to make changes, or the Department for Education changes the funding regulations.

Some options are age specific. For example, Care Home Visits are for pre-school children only whereas meals are applicable to all age groups. Please therefore select the preferred options for your child from based on their current age and options that would be relevant to them in the future. For example, you may have a 2-year-old child but when they turn 3 you would like them to go on the Care Home visits. You would then tick the opt-in for the Care Home. This additional charge would not be added to your invoice until they move to pre-school.

Similarly, you may have a 1-year-old who you wish to attend 'Cooking Club' when they move to the Toddler Room. You would therefore tick 'Cooking Club' as an opt-in and once they turn 2 years-old this will be added to the invoice.

By providing Grove Villa with a list of all the opt-in and opt-out preferences both now and in the future, it means that you are not required to fill a new agreement in each time your child moves up an age group.

- Opt-in selections are valid for the duration of your child's time at Grove Villa. These can be changed to an opt-out which would be effective from the start of the following term an require a minimum of one month's notice i.e., if you wanted to opt-out a particular service for the start of the Spring Term (1st January), notice of this must be given by the 1st December latest otherwise the opt-in service will remain until the start of the Summer Term (1st April).
- To opt-in for a service, you have opted out of, this can be done without notice.

The challenges the new DofE guidance has placed upon childcare providers (see Page 7) means that we must ask you to voluntarily agree to pay additional charges and has restricted what we can charge for. Grove Villa has always adopted a universal early year's funding policy that ensures that every child attending the setting has access to the same high quality childcare package. By the DofE dictating that we must give families the option to opt-in or out of the services and extracurricular activities that Grove Villa provides, it risks compromising our universal childcare model and means that children who are opted-out of certain services are not gaining the same experience and learning as those who opt-in. We do appreciate that ultimately it may come down to a financial decision as to the preferences you tick. It is however worth pointing out that even with all the opt-in options ticked, from 1st September, it would equate to less than the £2 per hour sustainability charge which ended on 31st August 2025.

Additional Hours Charge for a Part-Funded Session

This is a non-funded hours related charge for the balance of hours required for the remainder of your child's session once the weekly funding allocation is used up. From 1st September 2025, this will be £8.75 per hour (this is subject to change as part of fee reviews). As it is a 'private' fee, it will cover any meals, consumables and extra-curricular activities that take place once this part of the session commences. *Please note, this is the first increase in this rate in over 2 years.*

Additional Services Charges Rates

The cost for each additional service is valid from 1st September 2025. These are subject to change as part of Grove Villa's fee review process. We typically review fees early in the year with any fee changes effective from 1st April. At least one months-notice will be provided of any change in additional services costs.

Key to Age Groups on Additional Services Opt-In and Opt-Out Selection on following page:

- 9m+ = Children eligible for early years funding aged 9 months to 23 months old
- **Toddlers.** = Children eligible for early years funding aged 24 months to 35 months old (2-year old's)
- **Pre-School** = Children eligible for early years funding aged 36 months to school age (3–4-year-olds)
